EVIDENCE

Our SENCO starts by going through all of the professional evidence submitted as part of the EHC needs assessment and we highlight everything the experts have raised.

NEED

We then cross reference this with everything that has been contained in **Section B** (Educational Need) of the draft EHCP and make sure **everything** has been included.

If anything is missing, we'll advise you to challenge this and request amendment.

PROVISION

Once we're happy the plan captures your child's needs, we then move to **Section F**. This part of the plan outlines what special educational need provision is needed to meet your child's needs.

We'll make sure your plan is as specific and quantified as far as is possible. __

We then summarise all of this in your advice letter. You'll also receive a version of the plan with all of our suggested edits and comments

THE PROCESS



INITIAL CONSULTATION

- Face to face for local, or video call for our clients further afield. These appointments can take anywhere between 1 2 hours, depending on the complexity of your case.
- You'll meet with one of our specially trained, independent SENCOs, who'll take the time to record a full history of need, meet your young person (if they're willing and able), and truly capture yours and your child's voice.
- We'll then undertake a SENCO assessment of need in collaboration with you and explore your 'magic wand' wish list. For those needing further assessment, we can arrange Educational Psychology involvement with one of our EPs (additional fees apply).
- We'll then propose and agree a bespoke course of action, and explore how we can support you every step of the way.



YOUR RIGHTS, YOUR FIGHT

- Where necessary, we'll consult with other professionals within our panel on your behalf. This may include clinical professionals, legal professionals, social care professionals and/or Educational Psychologists. This is to ensure we've explored all avenues in your case. Please note, such consultations are advisory only and do not amount to legal advice or clinical/medical assessment and diagnosis.
- We'll then ensure you're fully up to speed with your rights and responsibilities, and that your child's voice is heard, loud and clear. Your Advocate will support you and represent you, as much or as little as you need, in your fight to secure the special educational needs provision that your child needs.

Form of Consent & Authority

I, the undersigned Client, hereby engage SENse Support Services to provide guidance, support, and representation in matters related to my child's special educational needs (SEN). I understand and consent to the following:

1. Representation and Communication:

I request and authorise the designated advocate to represent me and my child in discussions, meetings, and correspondence with educational institutions, professionals, and relevant parties involved in my child's special education.

2. Information Sharing: I give consent for the advocate to receive and share information related to my child's special educational needs with educational institutions, professionals, and other relevant parties, as required to facilitate effective advocacy and support.
